SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

Shall the Board of Directors of the Dallas Center – Grimes Community School District, in the County of Dallas, State of Iowa, change the method of election of its seven (7) directors, from three (3) directors elected at large by the electors of the entire district, no more than two at each regular school election, and election of the remaining four (4) directors as residents of and by the electors of individual geographic districts established on the basis of population and identified as director districts, no more than two at each regular school election, pursuant to Iowa Code Section 275.12(2)(e), to all seven (7) directors elected at large from the entire school district by the electors of the entire school district pursuant to Iowa Code Section 275.12(2)(a)?
