**WHO ARE THE PEER ADVOCATES?**

PEER Advocates are volunteers over the age of 60 who have completed an initial counseling skills training and participate in ongoing seminars. They are available to help other people, age 60 or older, with a variety of situations, concerns, problems, or questions.

**WHAT IS THE PEER ADVOCATE MISSION?**

To empower isolated elderly individuals and their families to participate in the decision making process and access resources that will help them to live independently and safely in the community.

**WHO CAN CALL THE PEER ADVOCATE PROGRAM?**

The PEER Advocate Program will accept a referral from anyone. We receive calls from persons calling for themselves, from neighbors, concerned friends, doctors, hospital social workers, and family members. If you are concerned about an older adult living in Polk County, please call.

**WHEN CAN I RECEIVE AN EMERGENCY MEAL?**

Emergency meals can be delivered after a recent hospitalization or other urgent need. A volunteer will deliver one hot meal and one cold meal each day for up to three days. Meals are purchased by the program from Hy-Vee Deli.

**WHAT OTHER ASSISTANCE IS PROVIDED?**

A PEER Advocate can help you to discover your options and access services.

Aside from the services we offer, we will be happy to assist seniors in seeking other relevant services.

**WHAT IS THE COST TO PARTICIPATE IN THE PEER ADVOCATE PROGRAM?**

All services are provided at no cost. Contributions to the program are greatly appreciated as they allow us to serve a greater number of clients.
