All voters are also advised as to the requirements of voter registration in order to be eligible to vote at said election. The above notice is given by order of the Des Moines Area Community College, and the Polk County Commissioner of Elections.

Machine testing shall commence from Tuesday, September 6th and continue until Monday, September 12th at various precincts throughout Polk County.
