**PUBLIC NOTICE** is hereby given to the qualified electors of the County of Polk, State of Iowa, that the Primary Election has been called and ordered to be held on Tuesday, June 4, 2024. The polls will be open from **7:00 AM until 8:00 PM**. The polling places to be used and list of the names of all candidates are listed within this publication. All voters must choose one ballot of the Democratic, Republican, or Libertarian party only. A ballot of each party appears in this publication and ballots of similarity shall appear in the proper precincts.

Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the Polk County Election Office at 286-3247 or [election@polkcountyiowa.gov](mailto:election@polkcountyiowa.gov). Public Machine testing will commence Tuesday, May 21st and continue until Monday, June 3rd at each precinct.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon, June 6th. Election Day Registrant attestors must provide an approved form of identification. I hereby certify that the ballots for each of the Democratic, Republican, and Libertarian parties to be used at this election shall be substantially in the form published within this publication. All qualified electors of the Polk County, Iowa are hereby notified to appear at said time and place, vote at the polling place designated, and advised as to the requirements of voter registration in order to be eligible to vote as authorized by law.

**Canvass Notice for Polk County Primary Election:** The Polk County Board of Supervisors will need to convene as a Canvassing Board on Tuesday, June 11, 2024 at 9:30 AM. The location will be the Supervisor's Board Room located on the first floor of the Polk County Building at 111 Court Avenue.
