### c) Employee Manual Revision: Hours of Work Section

The language in the Hours of Work section of the PCCB's Employee Manual indicates that if an employee is reporting to a PCCB park, trail or County facility for their first assignment of the day an employee is not entitled to paid time until they

reach the PCCB or County location they are assigned to. So if an employee is not reporting to a PCCB park, trail or a County facility for first assignment of the day, their paid time begins as soon as they leave for that assignment rather than when they reach their assigned location.

Because it is becoming more common for employees to report to locations other than a PCCB or County site/facility for their first assignment of the day, particularly for our Community Outreach and Environmental Education units, staff is proposing a change to this language.

Staff is also proposing that language indicating that event schedules related to conferences, workshops, meetings, etc. attended by employees be attached to employee's timesheets be removed. Timesheets are no longer being used for tracking employee time as PCCB is now using the County's Staff Scheduler program so employee time is tracked electronically. Supervisors will continue to review the schedule of the event with their employees to determine hours of work.

Attached is the Hours of Work section of the PCCB's Employee Manual with revisions.

**STAFF RECOMMENDATION:** That the Board approve the revisions to the Hours of Work section of the PCCB's Employee Manual.

#### **d) Mally's Park: Playground**

Polk County Conservation Board has been improving public access and amenities at Mally's Park for several years. The park users and local residents have been very supportive of all the improvements to date. One missing amenity and what we consider to be the capstone project is the playground. Providing a playground in conjunction with the other park improvements transforms Mally's from a local park to a community resource.

Local support has always been strong for park improvements but the future of Mally's as a trailhead and important trail junction make the improvements we are doing now important on an area wide basis. The future hub of the Chichaqua Valley Trail and the Gay Lea Wilson Trail planned for this site will bring thousands of trail users through Mally's each year, as such, this site will become a vital part of the Central Iowa Trail System. The restrooms, shelters, and playground will offer much needed services to the public.

Staff contacted four playground vendors asking for quotes on equipment and curbing for an area that is approximately 55' x 37'. We requested a T-Swing, but did not dictate what the other equipment needed to be. We indicated that we had \$10,000 - \$12,000 to purchase equipment and curbing. An additional \$2,000 - \$3,000 will be needed for softfall material, an accessible walkway, and other installation supplies.

Attached is a proposed quote, photo, and drawing from Cunningham Recreation. This quote provided the most "bang for our buck". Along with the T-Swing (includes both a belt swing and enclosed tot seat), the package also included the Canyon Ridge play structure that serves both older and younger children and features multiple play options. Features include: double zip slide, curved zip slide, ridge

climber, tunnel-up climber, twister climber, fun seat, click wheel and answer wheel, and transfer platform.

The total quote from Cunningham Recreation is \$12,164.45. An additional \$2,835.55 would be spent on the softfall, accessible walkway, and installation supplies. The total project cost would be no more than \$15,000. GOF has committed \$5,000 towards the project and PCCB has \$5,000 earmarked in our REAP budget. A Community Betterment Grant application was submitted to the Board of Supervisors for the remaining \$5,000.

**STAFF RECOMMENDATION:** That the Board authorize staff expending up to \$15,000 for the purchase of playground equipment and curbing from Cunningham Recreation, and for the purchase of softfall material, accessible walkway and installation supplies at Mally's Park.

**e) Equipment Purchase: Utility Vehicle**

The FY 2012-13 capital outlay budget includes \$13,000 to purchase a utility vehicle to replace a 1996 Kawasaki Mule 2520. Staff researched the purchase of a utility vehicle from the current State of Iowa DOT Grounds Care Equipment contract 4425-5 and found the John Deere XUV 625i Gator to meet our needs and specifications.

**STAFF RECOMMENDATION:** That the Board approve for FY 2012-13 the purchase of a John Deere XUV 625i Gator from the Van Wall Group for a price not to exceed \$12,441.42.

**f) Salary Increases & Benefits Package, FY 2012-13**

For pay and benefit purposes, Polk County Conservation Employees are considered "Management and Excluded" employees.

As in the past, there was a resolution from the Board of Supervisors extending the AFSCME negotiated benefits to the "Management and Excluded" classes of employees. Employees will pay a percentage of the premium cost up to 9% for single coverage, the amount to be determined by wage earnings, effective July 1, 2012. Department Heads will pay \$15 per month for single coverage and \$25 for family coverage.

The Board of Supervisors approved extending a 1.5% base salary increase (effective July 1, 2012) to Management/Supervisory, Excluded employees, and Department Heads on May 1, 2012. At that same time they approved converting the pay plans for Management/Supervisory and Excluded employees to an open salary range

system and decreasing the maximum amount of annual anniversary increases to 4% effective July 1, 2012.

A salary increase was not approved for seasonal employees; therefore, staff is not proposing an increase for PCCB seasonal/intermittent employees.

**STAFF RECOMMENDATION:** That the PCCB approve salary increase and benefit package for full-time and permanent part-time staff and the conversion of pay plans for Management/Supervisory and Excluded employees (which are the pay plans considered for PCCB employees) and the maximum amount of annual anniversary increases to 4%, per actions taken by the Polk County Board of Supervisors for fiscal year 2012-2013, effective July 1, 2012; and further exclude the Director from receiving this salary increase.

### 3) Public Hearing: Jester Park, Easement – MidAmerican Energy

A public hearing shall be held to determine if property requested for easement by MidAmerican Energy within Jester Park is no longer necessary for park purposes or will not interfere with park purposes.

With the addition of the Jester Park Elk/Bison viewing area as well as the increasing popularity of the Playscape site staff has planned on expanding the parking in this area. In order to expand the parking area a MidAmerican Energy transformer will need to be moved. The easement extension will be 10' x 70'. MidAmerican Energy requires a change in the current easement to perform this work.

**STAFF RECOMMENDATION:** That the Board determine that property as designated within Jester Park is no longer necessary for park purposes or will not interfere with park purposes and forwarding the same on to the Board of Supervisors for the conveyance of easement to MidAmerican Energy Company for the purpose of installing underground electric line on PCCB managed property.

### 4) Fort Des Moines, Land Transfer

Staff addressed the Des Moines School Board on June 5 concerning the proposed transfer of land adjacent to Fort Des Moines Park and an access easement.

The School Board will meet on June 19 to discuss and possibly gift the land and an easement to Polk County. If the School Board offers the land and easement to Polk County, we should be prepared to accept the gift.

**STAFF RECOMMENDATION:** That the Board approves staff accepting the gift of land and recording of the deed and easement documents, if offered by the Des Moines School Board.

### 5) Jester Park: Award Bid, Sediment Removal & Wetland Construction – Two Dam Pond

Polk County Conservation Board (PCCB) applied for and received a grant through the DNR Fish Habitat Program. The grant contains \$25,125.00 to complete pond dredging, wetland and sediment basin construction, and the installation of three

grade stabilization structures. PCCB's share of the grant \$ 2,792 has been earmarked and is available for use to complete the project.

PCCB sent out "Invitation to Bid" (ITB) packets to the four local companies (those that bid on the TM pond dredging) and also published a "Notice to Bidders" in the Des Moines Register. Bids will be received until June 12, 2012. PCC will reconcile the bids and bring a recommendation to the June 13 Board meeting.

## Hours of Work

---

Flexibility in the regular workday is permitted, as scheduled/approved by supervisor providing operational efficiency is maintained. Supervisors are to inform the PCCB office and Director of changes to the regular workday.

Workdays will be interrupted by an unpaid meal period of one-half hour. One fifteen-minute rest period during each half-day shift may be taken by all employees.

Employees traveling to and from an assigned normal work destination (defined as PCCB parks, PCCB trails, or County Office Building) for first assignment of the day will be on the employee's own time. For travel time to and from work for the second or additional assignment of the day, the employee will receive straight compensatory time.

Employees attending conferences, workshops, meetings, etc. required by PCCB shall review the schedule for the event with their supervisor prior to attending to determine hours of work for the day(s) employee is participating. This applies whether the event is one-day or several days. Copy of events schedule identifying hours of work approved and initialed by supervisor shall be attached to employee's timesheet.

Hours of work for employees on PCCB business that require the employee to stay away from home overnight will be based on what is approved by your supervisor and will not exceed the actual number of hours of the event's agenda unless driving time to and from the event applies.

Travel time to and from conferences, workshops, meetings, etc. shall be considered hours of work. Estimated travel time should be discussed with your supervisor and approved by your supervisor prior to the event.

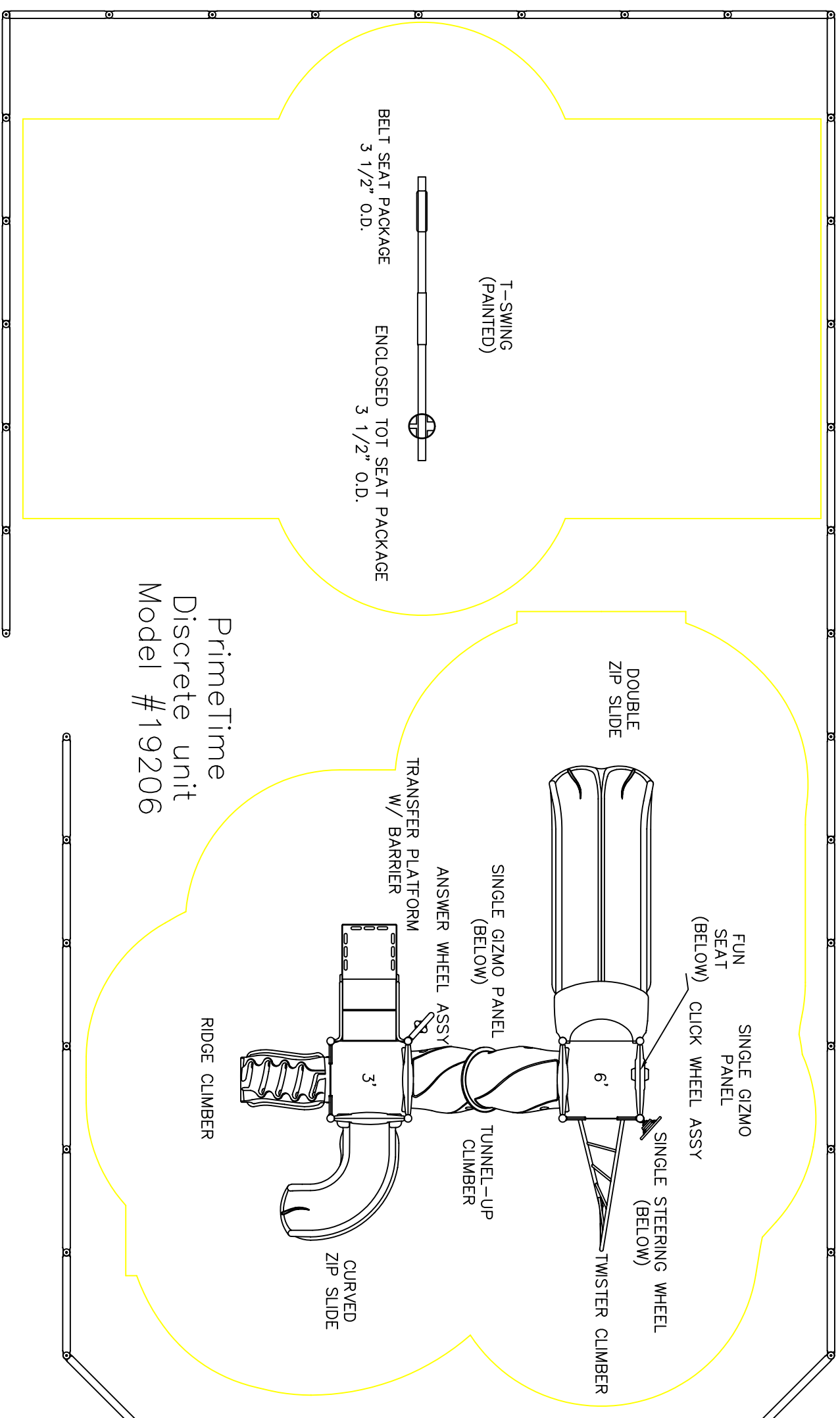
