Audit Findings

Audit Narrative

A PREA audit of the Polk County Jail was conducted July 9th – 11th, 2018 by Chris Sweney, Certified PREA auditor. As part of the audit a full tour of the facility was conducted along with three days of document reviews and staff and inmate interviews. The tour included all area of the main facilities including inmate housing, segregation unit, booking, kitchen, laundry, recreation, control, all program areas, medical and administration. Pre Audit posters where observed in all housing and common areas. No inmates specifically requested to speak with the audit team nor did the audit team receive any written correspondence from inmates or staff prior to the onsite visit.

On the first and second day of the audit the PREA Manager provided the auditor with a roster of staff assigned to each shift. A total of twelve (12) random staff interviews from all three shifts were conducted. Specialized staff interviews included the PREA Manager, booking staff, who also does the initial screening of inmates when arriving at the facility; Investigators responsible for PREA related investigations as well as medical staff, program staff and volunteers. A total of nineteen (19) formal staff interviews where completed.

On the second and third day of the audit the PREA Manager provided the auditor with a roster of all (1026) inmates at the facility. Inmates were randomly selected by the auditor. At least one inmate from each housing unit was interviewed. There were two inmates who spoke limited English interviewed. No inmates where identified that had hearing or visual impairments. Two inmates who identified as gay were interviewed as well as one transgender inmate. A total of forty-two (42) formal inmate interviews were completed. The Polk County Jail reported twenty-seven allegations of sexual abuse or harassment in the past twelve months. All incidents were investigated appropriately. Of the twenty-seven investigations six were substantiated, seven were unsubstantiated and fourteen were determined to be unfounded. After action reviews were completed for all substantiated and unsubstantiated allegations. The facility's response and investigative process was thoroughly reviewed with the PREA Manager and found to be well within standard.

Facility Characteristics

The Polk County Sheriff's Department operates an 1120 bed, direct-supervision facility. The Polk County Jail is located at 1985 NE 51st Place in Des Moines, Iowa. The facility has 1 single cell unit, 6 multi-occupancy cell unit and 12 dormitory style units. Housing is available for inmates of security levels ranging from minimum to maximum as well as protective custody and special management. Polk County has an extensive video monitoring system with more than 300 cameras which are continuously monitored and recorded. All staff and visitor access to the secure side of the jail is controlled at the front entrance. Visitors must present identification and sign in.

The Polk County Jail is a direct supervision facility and has a staffing plan which accounts for generally accepted detention and correctional practices; Polk follows applicable State and local laws, regulations and standards to determine staffing levels. The Polk Jail has no Judicial, Federal or other internal or external findings of inadequate staffing. All components of the facility's physical plant, composition of the inmate population and placement of supervisory staff are also considered.

Deviations from the staffing plan are documented and reported to the Sheriff. Staffing requirements are assessed annually and adjustments are made if necessary.

Unannounced rounds are completed by supervisors on each shift and documented in a permanent log book. The PREA Manager provided a copy of tour logs with the pre-audit documentation which shows this as a regular practice. During the onsite visit, supervisors demonstrate how unannounced rounds are documented. Random staff and inmate interviews also indicated that supervisors as well as administrative staff made regular rounds. Policy prohibits staff from alerting other staff members that supervisory rounds are occurring.

The Polk County Jail prohibits cross-gender strip searches and cross-gender visual body cavity searches. All strip searches are authorized by a supervisor and documented. The facility has implemented policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their buttocks, or genitalia, except when such viewing is incidental to routine checks. Staff is trained to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates using the least intrusive method possible. Staff interviews showed an understanding of the inmate search policy. Random inmate interviews and interviews with two transgender inmates revealed that searches are being conducted appropriately.

The Polk County Jail may claim an extension of time to respond, of up to 70 days, if the normal time period for response is insufficient to make an appropriate decision. The PREA Manager notifies the inmate in writing of any such extension and provides a date by which a decision will be made. At any level of the administrative process, including the final level, if the inmate does not receive a response within the time allotted for reply, including any properly noticed extension, the inmate may consider the absence of a response to be a denial at that level. Inmates may be disciplined for filing a false grievance related to alleged sexual assault/abuse only where the agency demonstrates that the inmate filed the grievance in bad faith. An inmate is not punished for reporting sexual assault/abuse in cases where the allegation is substantiated or unsubstantiated, as there is no proof in these cases that the alleged sexual violence did not happen.
