# FREE TAX PREPARATION.

**DO I QUALIFY?** You may qualify if you made \$57,000 or less in 2013.

## WHAT TO BRING

- ☑ Proof of identification
- ☑ Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration
- ☑ Birth dates for you, your spouse and dependents on the tax return
- ☑ Current year's tax package if you received one
- ☑ Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers
- ☑ Interest and dividend statements from banks (Forms 1099)
- ☑ A copy of last year's Federal and State returns
- ☑ Bank Routing Numbers and Account Numbers for Direct Deposit. Blank check or deposit slip required.
- ☑ Total paid for day care provider and the day care provider's tax identifying number (the provider's Social Security Number or the provider's business Employer Identification Number)
- ☑ To file taxes electronically on a married filing joint tax return, both spouses must be present to sign the required forms.

If you made \$57,000 or less, you may be eligible for....

- **\$6,044:** Maximum amount, with three or more qualifying children
- **\$5,372:** Maximum amount, with two qualifying children.
- **\$3,250:** Maximum amount, with one qualifying child.
- **\$487:** Maximum amount, with no children.
- **\$1,663:** The average refund amount in 2013!
