PUBLIC MEASURE LETTER MA SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?
"Shall the City of Mitchellville, in Jasper and Polk Counties, State of Iowa, enter into a loan agreement and issue general obligation bonds in an amount not exceeding \$1,500,000 for the purpose of paying the cost, to that extent, of constructing, improving, furnishing and equipping a municipal fire safety facility?"

Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the Polk County Election Office at 286-3247 or election@polkcountyiowa.gov. Public Machine testing will commence Monday, February 22 and continue until Monday, March 1 at each precinct.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon, March 4th. Election Day Registrant attestors must provide an approved form of identification. I hereby certify that the ballot to be used at this election shall be substantially in the form published within this publication. All qualified electors of the City of Mitchellville are hereby notified to appear at said time and place, vote at the polling place designated, and advised as to the requirements of voter registration in order to be eligible to vote as authorized by law.
