

**NOTICE OF ELECTION
CITY OF CARLISLE, IOWA
TO ISSUE GENERAL OBLIGATION CAPITAL LOAN NOTES**

Public Notice is hereby given that a City election of the City of Carlisle, Iowa, will be held on Tuesday, the 5th day of November, 2024, at which election there will be submitted to the registered voters of the City the following question, to-wit:

PUBLIC MEASURE LETTER B
Shall the following public measure be adopted?
<p>“Shall the City of Carlisle, State of Iowa, authorize a loan agreement and issue its General Obligation Capital Loan Notes in an amount not exceeding the amount of \$7,750,000 for the purpose of paying costs of designing, constructing, equipping, and furnishing a renovation and an addition to an existing building currently known as the Recreation Center to serve as a new City Library on city-owned property located at 1220 S. 5th Street, with parking improvements, signage, landscaping, and related site improvements?”</p>

The polls will be open from 7:00 AM until 8:00 PM and the polling place will be in the election precinct of the City of Carlisle within Polk County, and at the location described as follows:

At which election all of the registered voters of the City are hereby notified to appear at such time and place, each voter to vote at the polling place of the respective voting precinct in which such voter resides. All voters are also advised as to the requirements of voter registration in order to be eligible to vote at the election and that each voter is required to provide identification at the polling place before the voter can receive and cast a ballot. Voters who are not registered to vote in the precinct they are voting in, shall also be required to provide proof of residency. Voters also have the right to vote a provisional ballot or have a registered voter within the same precinct attest to their identity and residency if they are unable to provide proper identification. Voters who vote a provisional ballot shall provide the Polk County Election Office located at 120 2nd Ave., Des Moines, Iowa, 50309, by Tuesday at 12:00 PM on November 12, 2024 for their provisional ballot to be counted.

Any voter who is physically unable to enter a polling place has the right to vote in the voter’s vehicle. For further information, please contact the Polk County Election Office at 515-286-3247.

A ballot of similarity to be used in said election is published within this publication.

The Polk County Board of Supervisors will convene as a Canvassing Board on Wednesday, November 13, 2024 at 9:30 AM. The location will be the Supervisor’s Board Room located on the first floor of the Polk County Building at 111 Court Avenue, Des Moines, Iowa, 50309.
