The stated reason for the request is to subdivide the property to create a single-family residential development of 15 lots. The area of rezoning is an existing agricultural field. The Jester Park boundaries are located across NW 128 th Street to the east of the subject property. NW 128 th Street terminates approximately ½ mile north of the subject property. |
| Action Impact: | If the Rezoning Petition is approved, the Petitioners will move forward with a Major Subdivision process to create a new residential subdivision and likely generate additional adjacent requests. Denial of the Zoning Map Amendment leaves the property under its current "AG" Agricultural District zoning, and prohibits development to preserve prime farm land. |



Background: Polk County contracts with selected providers in Polk County to provide services to persons with mental illness, intellectual disability, or a developmental disability. If those providers are unable to meet the needs of a consumer and we must use an out-of-county provider or a local provider with whom we do not contract but who meets the criteria adopted by the Board of Supervisors in the Polk County Management plan. The Polk County Board of Supervisors has appointed the Polk County Service Appeal Board to review each request for services outside of Polk County or for services by local providers who the county does not contract with, to determine whether the service request is in the best interest of the consumer and the county, and to maintain client confidentiality.

Action Impact: The Polk County Service Appeal Board has determined that the services requested in the attached resolution are in the best interests of the consumers and the county. The Board of Supervisors in the counties where the providers are located have approved the proposed reimbursement rates. The attached cost summary outlines the services and the proposed costs that were reviewed and approved by the Service Appeal Board.

Background: Community, Family & Youth Services (CFYS) has the need for clinical consultation services at the Polk County Juvenile Detention Center (Detention Center). William Walker, a board certified diplomate in clinical consultation, is uniquely qualified to provide such services. Direct consultation with residents may occur upon referral by the Detention Program Administrator. The provision of on-site consultation services will help to ensure that staff and youth meet the goals set forth in individual care plans. As Detention clientele continue to present with complex mental health and behavioral issues, the services of an on-site clinical consultation with staff regarding specific cases.

Consultation will be provided for up to 6 hours per month with an additional 18 hours per year for staff training and staff/youth consultation at the rate of \$135 per hour. The total amount of this contract shall not exceed \$12,150 per fiscal year. This agreement is effective upon signing and shall continue through June 30, 2022.

Action Impact: Approval of this Agreement for Clinical Consultation Services will help the staff at the Detention Center continue to meet the needs identified in individual care plans for the youth being served.


